- ❖ Critiques will be made available to teachers at the conclusion of the competition; dancers will receive their critique sheets from their teachers.
- ❖ Age groups divided according to entries received. Age computed as of March 27, 2010
- ❖ Cash awards for the oldest premier section, medals for all others
- ❖ Choreography time limit is 3 minutes for Solo, 4 minute for group, music must be provided by competitor(s) at registration. Participation in solo choreography event is limited to Premier level dancers.
- ❖ Intermediate and Premier level dancers may enter to compete in Highland events, National events or both sections. Class trophies will be awarded to overall class winners in both Highland and National events.

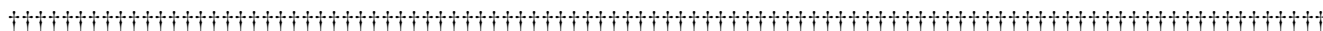
